## **Expression of Interest for Providing Automated Laundry Services in**

### **INDIAN INSTITUTE OF SCIENCE. Bangalore**

IISc invites Expression of interest (EOI) from reputed Organizations/Firms for providing of Automated Laundry services. IISc intends to provide the Automated laundry services for students and campus residents.

There are about 4000 students in the IISc campus Hostels. Over and above, the 500 Faculty and 1000 support staff of the campus can also avail the laundry services. The contract will be for a period of 1 year, renewable every year up to a maximum of 5 years on mutual agreement subject to satisfactory performance.

The bidding agency/firm shall have a minimum 2 (two) years of experience in providing mechanized laundry services to minimum 25,000 customers per year in Government /Autonomous Bodies / Public Sector Undertakings/ Educational Institutes/Corporate

The agency has to install high-end Washing Machines, Dryer, Electric Iron Facility, and other equipment / accessories as may be necessary for running the laundry services. The Agency/Firm shall bear all the expenses including water and electricity for running the in-house Automated laundry services.

IISc will provide the space on a standard licence fee of Rs. 10/ per SFT, subject to a hike of 5% every year. The agency has to pay licence fee as per the Institute rules from time to time and other charges like electricity & water as per actuals.

Bidding agency/firm preferably have the provision of online booking facility through website, mobile app & phone (customer care services).

**Use of Plastic is completely prohibited.** The agency should not use plastic covers/paper for wrapping and packaging.

The following is qualification criteria for short-listing the eligible agencies :

1. The agency/firm must be having PAN & GST number.

2. The agency/firm shall have a minimum 2 (two) years of experience in providing mechanized laundry services to minimum 25,000 customers per year in Government /Autonomous Bodies / Public Sector Undertakings/ Educational Institutes/Corporate offices.

3. The agency, on its own cost shall install sufficient mechanized washing infrastructure like high end washing machines, dryers, electric iron instrument & other equipment & accessories for running automated laundry services on campus.

4. Bidding agency/firm preferably have the provision of online booking facility through website, mobile app & phone (customer care services).

5. The agency should have annual turnover of Rs 50 Lakhs during the last 3 years.

The bidder has to make a presentation to the committee and the students representatives. The committee along with students representatives will visit the facilities of the agencies who have been shortlisted and assess the maintenance of their existing facilities.

The request for proposal will be extended only to the short-listed agencies in the evaluation. The agencies interested in providing services shall provide the details in the attached format.

The successful bidder has to enter into an agreement valid for a maximum period of 5 years with the Institute before commencement of services.

**Document Submission**: Provide the self-attested copies of the following along with your EoI:

a) Proof of registration under relevant law, such as Companies Act, and / or Shops & Establishment Act etc.

b) For partnership firms, full name and address of each partner along with certified copy of registered partnership deed, copy of trade license.

c) For proprietorship firms, full name and address of proprietor along with certified copy of trade license and

d) Copies of the valid trade license no., Labour license, PAN Card, PF Registration Certificate (if applicable), ESI Registration Certificate (if applicable), GST Registration number and your organization/ agency profile,

e) In case the agency is registered under MSME, NSIC certificate in the relevant sector duly attested may also be provided.

f) Tentative schedule of time required for start of operations
