CORRIGENDUM

Please refer Notice Inviting Tender from IRDA approved Insurance Companies for Group Mediclaim (Family Floater) Insurance Policy for IISc. Employees / Pensioners and their dependent family members.

The following amendments are made to the existing clauses

Page - 12

The limit for maximum premium value to be quoted in the matrix (Annexure-IVA) for top-up insurance coverage with reference to the age group "96 and above" is revised to Rs. 1,00,000/- from Rs. 75,000/-.

Page - 13

The limit for maximum premium value to be quoted in the matrix (Annexure-IVB) for top-up insurance coverage with reference to the age group "96 and above" is revised to Rs. 90,000/- from Rs. 75,000/-.

There is no change in Annexure - IVC
