Section 2 – Eligibility Criteria

Prequalification criteria:

- 1. The Bidder's firm should have existence for a minimum of 3 years. (Enclose Company Registration Certificate)
- 2. The Bidder should belong to either class 1 or class 2 supplier distinguished by their "local content" as defined by recent edits to GFR. They should mention clearly which class they belong to in the cover letter.
 - a) Class 1 supplier: Goods and services should have local content of equal to or more than 50%.
 - b) Class 2 supplier: Goods and services should have local content of equal to or more than 20 % and less than 50%.
- 3. Purchase preference as defined by the recent edits to GFR (within the "margin of purchase preference") will be given to Class-1 supplier.
- 4. MSME can seek exemption to some qualification criteria. IISc follows GFR2017 for such details
- 5. The bidder should sign and submit the declaration for Acceptance of Terms and Conditions as per -Annexure 4.
- 6. The Bidder must not be blacklisted/banned/suspended or have a record of any servicerelated dispute with any organization in India or elsewhere. A declaration to this effect has to be given as per Annexure 3.
- 7. The Bidder should have supplied similar equipment in Central Unversities preferably in centrally Funded Technical Institutes (IITs, IISC, IISER, NIT). Please provide the details and contact informations.

Section 3 – Terms and Conditions

A) Submission of Tender:

- 1. All documentations in the tender should be in English.
- 2. Tender should be submitted in two envelops (two bid system).
 - a. Technical Bid (Part-A) Technical bid consisting of all technical details and check list for conformance to technical specifications.

The technical proposal should contain a technical compliance table with 5 columns.

i. The first column must list the technical requirements, in the order that they are given in the technical requirement below.

ii. The second column should provide specifications of the instrument against the requirement. Please provide quantitative responses wherever possible.iii. The third column should describe your compliance with a "Yes" or "No"

only. Ensure that the entries in column 2 and column 3 are consistent. iv. The fourth column should state the reasons/explanations/context for deviations, if any.

v. The fifth column can contain additional remarks from the OEM. You can use this opportunity to highlight technical features, qualify response of previous columns, or provide additional details.

- b. Commercial Bid (Part-B) Indicating item wise price for the items mentioned in the technical bid, **as per the format of quotation provided in tender**, and other commercial terms and conditions.
- 3. The technical bid and price bid should each be placed in sparate sealed covers, superscripting on both the envelopes the tender no. and the due date. Both these sealed covers are to be placed in a bigger cover which should also be sealed and duly superscripted with the Tender No, Tender Description & Due Date.
- 4. The SEALED COVER superscripting tender number / due date & should reach Chairperson Office, Instrumentation and Applied Physics, Indian Institute of Science, Bangalore – 560012, India on or before due date mentioned in the tender notice. In case due date happens to be holiday the tender will be accepted and opened on the next working day. If the quotation cover is not sealed, it will be rejected.
- 5. All queries are to be addressed to the person identified in "Section 1 Bid Schedule" of the tender notice.
- 6. The items are required for research purposes, and IISc is a DSIR registered institution, hence eligible for GST exemption (i.e. GST @ 5%). While submitting the price quote, this point must be taken care. For getting GST exemption certificate, successful bidders must submit, a formal request together with Invoice copy and Purchase order copy.

- 7. The price must be quoted in INR (Indian Rupee).
- 8. If price is not quoted in Commercial Bid as per the format provided in tender document the bid is liable to be rejected.
- 9. The Institute reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to the award of contract, without there by incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders.
- 10. Incomplete bids will be summarily rejected.

B) Cancellation of Tender:

Notwithstanding anything specified in this tender document, IISc Bangalore, in its sole discretion, unconditionally and without having to assign any reason, reserves the rights:

- a. To accept OR reject lowest tender or any other tender or all the tenders.
- b. To accept any tender in full or in part.
- c. To reject the tender, offer not confirming to the tender terms.

C) Validity of the Offer:

The offer shall be valid 90 Days from the date of opening of the commercial bid.

D) Evaluation of Offer:

- 1. The technical bid (Part A) will be opened first and evaluated.
- 2. Bidders meeting the required eligibility criteria as stated in Section 2 of this document shall only be considered for Commercial Bid (Part B) opening. Further, agencies not furnishing the documentary evidence as required will not be considered.
- 3. Pre- qualification of the bidders shall not imply final acceptance of the Commercial Bid. The agency may be rejected at any point during technical evaluation or during commercial evaluation. The decision in regard to acceptance and / or rejection of any offer in part or full shall be the sole discretion of IISc Bangalore, and decision in this regard shall be binding on the bidders.
- 4. The award of contract will be subject to acceptance of the terms and conditions stated in this tender.
- 5. Any offer which deviates from the vital conditions (as illustrated below) of the tender is liable to be rejected:
 - a. Non-submission of complete offers.
 - b. Receipt of bids after due date and time and or by email / fax (unless specified otherwise).

- c. Receipt of bids in open conditions.
- 6. In case any BIDDER is silent on any clauses mentioned in these tender documents, IISc Bangalore shall construe that the BIDDER had accepted the clauses as of the tender and no further claim will be entertained.
- 7. No revision in the terms and conditions quoted in the offer will be entertained after the last date and time fixed for receipt of tenders.
- 8. Lowest bid will be calculated based on the total price of all items tendered for Basic equipment along with accessories selected for installation, operation, preprocessing and post processing, optional items, recommended spares, warranty, annual maintenance contract.

E) Pre-requisites:

The bidder will provide the prerequisite installation requirement of the equipment along with the technical bid.

F) Warranty:

The complete system is to be under warranty period of minimum 3 years (year wise breakup value should be shown in the commercial bid) including free supply of consumables, spare parts and data analysis software from the date of functional installation. If the instrument is found to be defective, it has to be replaced or rectified at the cost of the bidder within 30 days from the date of receipt of written communications from IISc, Bangalore. If there is any delay in replacement or rectification, the warranty period should be correspondingly extended.

G) Annual Maintenance Contract:

An annual maintenance contract for a period of atleast 2 years post warranty should be provided on completion of warranty period. The AMC costs will not be considered towards classifying the domestic nature (class 1 or class 2) of the vendor (see eligibility criteria in section 2). In the bid AMC charge should also be provided.

H) Purchase Order:

- 1. The order will be placed on the bidder whose bid is accepted by IISc based on the terms & conditions mentioned in the tender document.
- 2. The quantity of the items in tender is only indicative. IISc, Bangalore reserves the right to increase /decrease the quantity of the items depending on the requirement.
- 3. If the quality of the product and service provided is not found satisfactory, IISc, Bangalore reserves the right to cancel or amend the contract.

I) Delivery, Installation and Training:

The bidder shall provide the lead time to delivery, installation and made functional at IISc, Bangalore from the date of receipt of purchase order. The system should be delivered, installed and made functional **within 90 days** from the date of receipt of purchase order. The supply of the items will be considered as effected only on satisfactory installation and inspection of the system and inspection of all the items and features/capabilities tested by the IISc, Bangalore. After successful installation and inspection, the date of taking over of entire system by the IISc, Bangalore shall be taken as the start of the warranty period. No partial shipment is allowed.

The bidder should also arrange for technical training to the local facility technologists and users.

J) Payment Terms:

100% payments (except AMC) will be released after completion delivery and satisfactory installation subject to TDS as per rules. AMC cost (if ordered), after completion of warranty period) will be released on half-yearly basis at the end of each six months subject to satisfactory services. The AMC will be comprehensive. Price basis must be on FOR-IISc Bangalore basis only.. As per GFR no advance payment can be made to domestic vendors, unless an equal amount of bank guarentee is provided.

K) Statutory Variation:

Any statutory increase in the taxes and duties subsequent to bidder's offer, if it takes place within the original contractual delivery date, will be borne by IISc, Bangalore subject to the claim being supported by documentary evidence. However, if any decrease takes place the advantage will have to be passed on to IISc, Bangalore.

L) Disputes and Jurisdiction:

Any legal disputes arising out of any breach of contract pertaining to this tender shall be settled in the court of competent jurisdiction located within the city of Bangalore, India.

M) General:

- 1. All amendments, time extension, clarifications etc., within the period of submission of the tender will be communicated electronically. No extension in the bid due date/time shall be considered on account of delay in receipt of any document(s) by mail.
- 2. The bidder may furnish any additional information, which is necessary to establish capabilities to successfully complete the envisaged work. It is however, advised not to furnish superfluous information.
- 3. The bidder may visit the installation site before submission of tender, with prior intimation.
- 4. Any information furnished by the bidder found to be incorrect, either immediately or at a later date, would render the bidder liable to be debarred from tendering/taking up of work in IISc, Bangalore.

Section 4 – Technical Specifications

A. Technical Specifications of the thermal and UV based nanoimprinter

A desktop or floor-mounted system capable of operating with 220 volts line power and performing pressure-driven thermal nanoimprint lithography, UV nanoimprint lithography, and hot embossing under vacuum or ambient pressure.

The system should meet or exceed the following minimum specifications. A compliance sheet with respect to our specification and your quoted system should be included while submitting the tender.

B. Spares and accessories

- At least one hard stamp and one soft test stamp with anti-sticking coating to demonstrate (i) UV nanoimprint lithography and (ii) thermal nanoimprint lithography. The stamp to demonstrate nanoimprint lithography must have a minimum feature size of 50 nm or less.
- At least 100 ml of a UV nanoimprint photoresist and 100 ml of the corresponding developer.
- At least 100 ml of a UV nanoimprint photoresist and 100 ml of the corresponding developer.
- At least 100 ml volume of an adhesion promoter for the photoresist.

Computer and software

- A workstation (Dell or Lenovo or HP or equivalent) compatible with the nanolithography equipment and loaded with genuine 64-Bit operating system and pre-installed software for operating the equipment. Please quote for a perpetual license or extended support for the software.
- At least one standard recipe for each of the following should be pre-installed for initial training and familiarization of the system: (i) thermal nanoimprinting of a Polycarbonate (PC) using PDMS stamp, (ii) thermal nanoimprint on a resist, (iii) UV nanoimprint with a photoresist for use with hard stamps, (iv) UV nanoimprint with a photoresist for use with PDMS stamps.
- Front panel displaying equipment and process status along with appropriate software to be supplied.
- The software must allow varying levels of instrument access. A simplified basic access for a user to a full access to an engineer.
- Complete logs of all the process and system parameters to be available and stored for future trouble shooting
- Display tool and process parameters
- Provision to alert the user in case of emergencies may be included
- Software need to be supported for the lifetime of the tool.

Warranty (to be included in the quote)

- The system should carry 3 warranty and 2 years of comprehensive maintenance contract (CMC) after the first year of warranty for all spare parts and service— this is extremely important for us.
- Warranty will start from the day of installation of the equipment.
- Support for spare parts for xx years after sale and installation should be quoted.

C. Training and demonstration

• Complete installation including demonstration of individual and combined UV and thermal nanoimprint processes with a feature size of at least 50 nm using the test stamp

- Training for users by the company personnel present 'on site' immediately after the installation.
- All pre-installation requirements to have the system installed in ideal room conditions should be included in the quote.

D. Others

- The system must submit references from atleast 3 previous installations
- The names and contact addresses of the referees must be submitted with the proposal, so the purchase committee can contact them independently.
- The system should require minimal maintenance.
- Mention the recommended preventive maintenance schedule for the system. Any accessories needed for periodic preventive maintenance for 3 years, should be mentioned in separately the itemized quote.
- Can the preventive maintenance be done by a trained on-site engineer or requires a specialist from the OEM? If the latter, please provide cost of a 3 year AMC with required kit/consumables.
- The system should be supported by a trained local representative and should have a 48hour window of response.
