IMPORTANT ANNOUNCEMENT

Course Completion Certificate (CCC)/Provisional Degree Certificate(PDC)

It has been brought to our notice that in some universities/colleges, final year examinations are likely to finish only by August 2021. Therefore, to help the students, IISc has decided to provide the following options to the applicants offered admission in various programmes.

1. **Programme: MTech/M Des/Master of Management and Integrated PhD**
 - (a) Applicants are allowed to submit a Course Completion Certificate (CCC) on or before **September 1, 2021**, subject to uploading of the university examination calendar or certificate issued by Registrar/Controller of examination mentioning the last date of exam for the applicant's Course **on or before July 25, 2021**, on the admission portal. **The last date of the examination should not be later than August 15, 2021.**
 - (b) The applicant must upload the document mentioned in para (a) above under the heading "course completion certificate" on the admission portal by **July 25, 2021**.
 - (c) It may be noted that the applicant will be given provisional admission only after submission of CCC/PDC. The scholarship will begin from the date of provisional admission to the applicant.
 - (d) Applicants are not allowed to defer admission to the January 2022 or the August 2022 session.
 - (e) The Institute will try to make necessary arrangements so that applicants who have paid the admission fee and have uploaded the document mentioned in para (a) above can join the online classes until they are given provisional admission.

2. **Research Admission [PhD/MTech(Research)]:** Applicants offered admission to the Research programme can exercise either one of the two options below subject to producing relevant documents.

Option 1:

- a) Applicants are allowed to submit a Course Completion Certificate (CCC) on or before **September 1, 2021**, subject to uploading of the university examination calendar or certificate issued by Registrar/Controller of examination mentioning the last date of exam for the applicant's Course, **on or before July 25, 2021** on the admission portal. **The last date of the examination should not be later than August 15, 2021.**
- b) The applicant must upload the document mentioned in para (a) above under the heading "course completion certificate" on the admission portal by **July 25, 2021**.
- c) It may be noted that the applicant will be given provisional admission only after submission of CCC/PDC. The scholarship will begin from the date of provisional admission to the applicant.
- d) Institute will try to make necessary arrangements so that applicants who have paid the admission fee and have uploaded the document mentioned in para (a) above can join the online classes until they are given provisional admission.

Option 2:

- (a) Applicants may defer their admission to the January 2022 session, subject to the applicant producing a document issued by Registrar/Controller of Examination of the university stating that the university examinations for the applicant's Course have been postponed/scheduled beyond **August 15, 2021**.
- (b) A request for deferment of admission along with the document mentioned in para (a) above should be uploaded on the admission portal under the heading "course completion certificate" by **July 25, 2021**. Also, the applicant is required to send a deferment of admission request to admission.acad@iisc.ac.in /ar.acad@iisc.ac.in.
- (c) Course completion certificate / Provisional Degree Certificate must be submitted on or before **November 1, 2021**.
- (d) A new admission letter will be sent to the applicant after **December 15, 2021**.
- (e) Deferment of admission to the August 2022 session is not allowed.
