NUMBER OF POSTS: 01 **Category:** General (unreserved)

ESSENTIAL QUALIFICATIONS: Masters Degree in Civil Engineering from a recognized University with a minimum of 55% marks

ESSENTIAL EXPERIENCE: At least 15 years of experience in relevant field as Engineer / (GP of Rs. 5400/-) or higher level from CPWD, State PWD or semi-Govt. / PSU / Statutory or Autonomous organization / University / Institutions of national importance/ reputed organization under Central / State Govt. of which 5 years should be as senior executive Engineer with a GP of Rs. 7600/- or its equivalent grade. In case of contract appointment, those having at least 15 years of experience in relevant field as a Senior level Engineer for infrastructure development/management in private sector such as corporate / private industries or reputed infrastructure firms or builders / institutions can also apply.

DESIRABLE: Experience in development or operation or maintenance of a modern academic or corporate or similar infrastructure. Familiarity with modern practices in civil constructions and electrical power systems.

PAY LEVEL: Level 13 (Rs. 1,23,100- Rs. 2,15,900)

AGE: The candidate should not have crossed 55 years of age as on 04.02.2022

Tenure of appointment: Deputation/contract basis for tenure of up to 5 years or till attaining the age of 60 years whichever is earlier

JOB DESCRIPTION: The PE-cum-EO is in charge of the estate and looks after all the infrastructure projects and its maintenance.

Terms and conditions:

1. The candidate must be a citizen of India. The prescribed qualifications and experience are the minimum required and the mere fact that a candidate possesses the same will not entitle him/her for being called for an interview. The Institute reserves the right to restrict the number of candidates admitted for interview to a reasonable number, on the basis of

2. Selection will be made on the basis of the candidate's previous track record and their performance in an interview.

 4. Candidates have to apply online only. Incomplete applications in any respect will not be considered. Physical application will not be considered.
 5. Deputation can be considered from the officers from the Central/ State Governments or Institute of national importance or Universities/ University level institution or PSU

 - ii) Possessing educational qualification and experience as prescribed mentioned in the advertisement
 6. Candidates working in government institutions/organisations should apply through proper channel along with NOC and vigilance clearance. The production of the same is mandatory before the interview.

 8. The recruitment through contract has a probation of one year.
