Job Description

The responsibilities of the selected candidates include (but not limited to) supervise civil/electrical works (as applicable to the posts), supervise/prepare (as applicable) estimates for the civil/electrical works, preparation of bills, processing of bills for payment, and carryout other woks assigned by the Project Engineer-cum-Estate Officer from time to time. The candidates are also required to supervise/work (as applicable) on e-tendering, preparation of presentation materials, tender processing etc.

How to Apply

- a. Candidates who are desirous to be considered strictly on the aforesaid terms and conditions may fill the online application form on the link given below duly attaching the required certificates in support of age, category, qualification, marks, disability, and experience on or before 07.03.2022.
- b. The selection will be based on interview. The shortlisted candidates will be informed through e-mail about date & time of interview. Candidates are also advised to provide correct information in their online application.
- c. Candidates may please ensure that they are fulfilling all the requisite criteria prior to registering, failing which, their candidature is liable to be rejected/cancelled.

General Instructions

- a. The Candidate must possess the essential prescribed qualifications on or before the last date of submitting application.
- b. These are annual contract positions and are subject to annual review and renewal. However, the engagement may be terminated by either side without cause with one month notice or salary in lieu thereof. The decision of the Institute in this regard shall be final and binding on the candidate. The duration of the contract is for one year initially and extendable up to **three years** on a yearly basis, subject to satisfactory performance and conduct.
- c. The age of candidate should be below the prescribed age-limit as above, as on the last date of receipt of application. Relaxation in age is applicable as per GOI norms.
- d. Qualifications other than one prescribed in this advertisement will not be accepted.
- e. Engagement on contract would be subject to medical fitness.
- f. Except the consolidated and fixed emoluments, no other benefits will be extended.
