# <u>Section 2 – Eligibility Criteria</u>

Prequalification criteria:

1. The Bidder's firm should have existence for a minimum of 3 years. (Enclose Company Registration Certificate)

## Section 3 – Terms and Conditions

## A) Submission of Tender:

1.All documentations in the tender should be in English.

2. Tender should be submitted in **two separate envelops** (two bid system).

a. Technical Bid (Part-A) – Technical bid consisting of all technical details and check list for conformance to technical specifications.

# C) Validity of the Offer:

The offer shall be valid 90 Days from the date of opening of the commercial bid.

# **D) Evaluation of Offer:**

1. The technical bid (Part A) will be opened first and evaluated.

2. Bidders meeting the required eligibility criteria as stated in Section 2 of this document shall only be considered for Commercial Bid (Part B) opening. Further, agencies not furnishing the documentary evidence as required will not be considered.

3. Pre- qualification of the bidders shall not imply final acceptance of the Commercial Bid. The agency may be rejected at any point during technical evaluation or during commercial evaluation. # **E) Pre-requisites:**

The bidder will provide the prerequisite installation requirement of the equipment along with the technical bid.

# F) Warranty:

The complete system is to be under warranty period of minimum 1 years (year wise breakup value should be shown in the commercial bid) including free supply of consumables, spare parts and data analysis software from the date of functional installation. If the instrument is found to be defective, it has to be replaced or rectified at the cost of the bidder within 30 days from the date of receipt of written communications from Purchase Committee IISc, Bangalore. If there is any delay in replacement or rectification, the warranty period should be correspondingly extended.

# **G)** Annual Maintenance Contract:

An annual maintenance contract for a period of at least 2 years post warranty should be provided on completion of warranty period. The AMC costs will not be considered towards classifying the domestic nature (class 1 or class 2) of the vendor (see eligibility criteria in section 2). # H) Purchase Order:

# I) Delivery, Installation and Training:

After successful installation and inspection, the date of taking over of entire system by the IISc, Bangalore shall be taken as the start of the warranty period. No partial shipment is allowed.
