## **ENGAGEMENT OF IPHD INSTRUCTOR**

The Indian Institute of Science (IISc), a leading institution for research in science and engineering, runs an Integrated PhD Programme for several years now. Details of the Programme can be found on the Institute web site http://www.iisc.ac.in/

In this context, IISc invites applications for the position of **01** Instructor for the Integrated PhD Programme to help in conducting laboratory courses of this Program in the discipline of Chemistry.

**Eligibility:** PhD in Chemistry with at least 2 years of postdoctoral experience, preferably in organic or inorganic and physical chemistry specialization.

**Desirable:** Candidates having a passion for teaching, especially in laboratory instruction and a prior research/teaching experience will be added as an advantage.

**Age:** Below 35 years as on the last date for receipt of applications. Relaxation in age is applicable as per GOI norms.

**Duration:** The above position is purely contractual, and candidates will be hired on a renewable annual contract (depending on satisfactory performance) for a maximum duration of 5 years. Contract tenure will commence from the date of joining. The waitlist will be operational for six months.

**Salary:** Instructor pay will be fixed in the range of Rs. 54,000 - 5,000 - 74,000 + HRA per month. The salary will be fixed based on the experience.

**Job Description:** The Instructor should be prepared to take overall charge of the Integrated Ph.D. laboratories, responsible for the maintenance of the laboratories and for conducting laboratory courses in consultation with the Institute faculty. The Instructor would also help design and evolve the laboratory/lecture curriculum and may also need to assist in the conduct of tutorial classes, course material preparation (both print and electronic versions) and evaluation of students. Further, he/she would help the Co-ordinator in the general administration of the Programme.

## **How to Apply**

- a) Candidates who are desirous to be considered strictly on the aforesaid terms and conditions may send their CV/Application (current CV, Account of past experience if any, Statement of interest) mentioning in the subject line "Application for the position of \_\_\_\_\_\_\_" duly attaching all the required documents as a single PDF file attachment to psm@iisc.ac.in on or before 22.04.2022.
- b) The eligible applicants will be called for an interview and the date & time of interview will be informed through e-mail. Candidates are also advised to provide correct information in their CV/application.

- c) No TA/DA shall be paid for attending the interview.
- d) Candidates may please ensure that they are fulfilling all the requisite criteria prior to registering, failing which, their candidature is liable to be rejected/cancelled.

## **General Instructions**

- a. The Candidate must possess the essential prescribed qualifications on or before the last date of submitting application.
- b. These are annual contract positions and are subject to annual review and renewal. However, the engagement may be terminated by either side without cause with one month notice or salary in lieu thereof. The decision of the Institute in this regard shall be final and binding on the candidate. The duration of the contract is for one year initially and extendable up to **five years** on a yearly basis, subject to satisfactory performance and conduct.
- c. The age of candidate should be below the prescribed age-limit as above, as on the last date of receipt of application. Relaxation in age is applicable as per GOI norms.
- d. Qualifications other than one prescribed in this advertisement will not be accepted.
- e. Engagement on contract would be subject to medical fitness.
- f. Except the consolidated and fixed emoluments, no other benefits will be extended.
- g. Candidature/contract of candidate(s) submitting false certificates or suppression/submission of incorrect information shall be liable for termination/disqualification/rejection at any stage.
- h. Candidates should send the applications via above mentioned email id only. No hardcopies will be accepted.
- i. Prescribed educational qualifications and experience are the minimum eligibilities required and mere fact that a candidate possesses the same shall not entitle him/her for being called for test/interview. The Institute reserves the right to restrict the no. of candidates admitted for interview to a reasonable number, based on qualifications and/or experience.
- j. Applications should be sent well in advance, without waiting till the last date.
- k. Call letters to attend interview will be sent only to the shortlisted candidates by mail. Candidates are required to check their registered e-mail ID frequently. No correspondence will be made with applicants who are not short-listed/not called for interview.
- I. The Institute reserves the right to reject any application without assigning any reason. The Institute also reserves the right to cancel the advertisement/ recruitment at any stage without assigning any reasons. No correspondence will be entertained in this regard.
- m. The Institute reserves the right to verify the antecedents or documents submitted by the candidate at any time during the service. In case it is found that the documents submitted by the candidate are not genuine, then his/her services shall be terminated, and disciplinary/criminal proceedings will be initiated.
