The *Interdisciplinary Centre of Energy Research (ICER)*, Indian Institute of Science Bangalore, invites tenders for supply of "<u>Upgradation of existing Rack Mountable 192</u> <u>Cores Server System to 384 Cores Server System</u>". This Invitation for Bids is open to only domestic (India based) manufacturers, Indian OEM, or its authorized Indian distributors.

The upgradation of the server includes Supply, installation and configuration of an additional Rack Mountable 192 Cores 2U Server System compatible with the existing 192 Cores Server System.

This is a **Request for quote (RFQ)** from **Indian Agencies** for supply of "<u>Upgradation of existing Rack Mountable 192 Cores Server System to 384 Cores Server System</u>" at the "Interdisciplinary Centre of Energy Research (ICER), Indian Institute of Science, Bangalore.

<u>This Invitation for Bids is open to only domestic (India based) manufacturers, Indian OEM, or its authorized Indian distributors.</u> All interested vendors shall submit a response demonstrating their capabilities to produce the requested equipment to the primary point of contact listed below.

With respect to this tender, the rules laid out by the Government of India in order No. P45021/2/2017-pp-BE-II issued by the Public Procurement Section, Department or Promotion of Industry and Internal Trade, Ministry of Commerce, and Industry, dated 4th June 2020 will be followed. As per the order the government has defined a 'Class-I local supplier' as "a supplier or service provider whose goods, services or work offered for procurement, has local content equal to or more than 50%". A 'Class-II local supplier' is "a supplier or service provider, whose goods, services or works offered for procurement, has local content more than 20% but less than 50%". Only Class-I and Class-II local suppliers are eligible to participate in this open domestic tender. Any "Non-local supplier" i.e., "a supplier or service provider, whose goods, services or works offered for procurement less than 20%" is ineligible to participate in this tender.

The deadline for submission of proposals is on or before <u>15th April 2022 by 5 pm</u>. Proposals should arrive at the office of The Chair, Interdisciplinary Centre of Energy Research (ICER), Indian Institute of Science, Bangalore, Karnataka 560012, India.

6) Optional requirements:

a) Warranty: 3 years warranty to be provided from the date of delivery at IISc, Bangalore.

The Technical bid must include all the details of technical specifications of the equipment, compliance certificate along with commercial terms and conditions, **however**, **without the price component**. The bill of materials printed technical brochure and any other documents to help the technical evaluation of the bid may be enclosed.

- 1. The commercial bid must include the price of the item(s) in Indian/Foreign currency indicating the breakup of
 - a) For Goods manufactured within India
 - (i) The price of the goods quoted Ex-works including taxes already paid.

(ii) GST and other taxes like excise duty, entry tax and other applicable taxes which will be payable on the goods if the contract is awarded.

(iii) The charges for inland transportation, insurance and other local services required for delivering the goods to IISc, Bangalore.

(iv) The installation, commissioning and training charges including any incidental services, if any with applicable service taxes.

2. The invoice to be billed at 5% GST for which concessional GST certificate will be

provided to the vendor.

- 3. Please indicate the import code of the items.
- 4. If the goods are found to be defective, they have to be replaced / rectified at the cost of the supplier within 15 days from the date of receipt of written communication from us. If there is any delay in replacement / rectification, the warranty period should be correspondingly extended.
- 5. The quotation should be on FOR-IISc Bangalore basis in INR only.
- 6. Conditional tenders shall not be accepted.

- 7. Bids shall remain valid for minimum of 90 days after the date of bid opening prescribed by the Purchaser.
- 8. The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidders.
- 9. The bidder should have established track record of supply, installation, and configuration of Rack Mountable 192 Cores Server System.
- 10. Technical support for 5 years must be provided.
