A. The details of the post is as follows :

## B. Desirable Qualifications :

- a) The individual should be energetic, proactive, and should have excellent written and oral communication skills in English.
- b) Ability to effectively use modern document preparation, electronic presentation, note taking, and networking applications and tools.
- c) Excellent organisational and interpersonal skills are essential.
- d) Experience in advising students at graduate and undergraduate level, will be distinct advantages.
- e) Advisor to International Students and Scholars is expected to work in consultation with a committee of professors and existing staff in the Office of International Relations at IISc. 1-2 years of work experience in similar role will be advantageous.

## C. Responsibilities:

- a) Work with international students and scholars at IISc.
- b) Help advertise IISc academic programs to international universities and agencies.
- c) Help in conducting interviews for admissions of international students.
- d) Help and guide international students and scholar, including visa processes.
- e) Organize events for international students and scholars (e.g., sports day, international day, etc.) on regular interval.
- f) Counsel international students.
- **D.** Age: Below 45 years as on the last date for receipt of applications. Relaxation in age is applicable as per Gol norms. However, the candidates should not have crossed 55 years as on the last date of receipt of application.
- **E. Duration:** Engagement is purely temporary on contract basis for a period of five years which will be renewable on an annual basis based on satisfactory performance. Contract tenure will commence from the date of joining.
