## Tender Pre-bid clarification meeting held on 04/07/2022 and Corrigendum 1

Please refer to Notice Inviting Tender dated 27.06.2022 from IRDA-approved Insurance companies for Group Mediclaim Insurance Policy for IISc. Students/ Project Staff/ Temporary Staff.

The pre-bid was held on 04.07.2022 at 3.30 pm through the Teams platform. The following queries were raised by the participant companies regarding the tender clauses.

1	Under Clause No 1, Page 10 of the tender document it is referred as "Further Contract employees under contractor may also be allowed to enroll for health insurance if they wish to be covered under the policy for which the premium will be paid directly by the contractor to the Insurance agency.	The said clause may be read as "Further Contract employees under contractor may also be allowed to enroll for health insurance. if they wish to be covered under the policy for which the contractor if he wishes can pay the premium to IISc. IISc will in turn pay to the Insurance agency to cover the said contract staff"
2	Whether spouse married before the inception of the policy i.e 01.08.2022 are allowed to enroll after the inception of the policy	The project staff/student/contract staff who are married before 01.08.2022 are to be enrolled before the inception of the policy. Addition of spouse who is married before 01.08.2022 are not allowed for midterms addition of the policy. However spouse married after 01.08.2022 are allowed as mid-term addition to the policy without any time limit.
3	Whether Psychiatric and wellness reimbursement is capped at Rs 40000/- only for IPD	Psychiatric Ailments and wellness treatment is capped at Rs 40000/- only for IPD.
4	Bidders have requested for sharing the Claim Dump analysis document, Active list of members, latest terms and conditions of Insurance policy.	Bidders are requested to send an email request to vasanthan@iisc.ac.in. The details will be shared without sharing any personal details
5	Annexure II of the financial bid	The Column "Total Premium per student (Including GST) may be read as " <b>Total Premium per</b> <b>person(Including GST)</b> ". The column <u>Total premium</u> <u>per Project Staff (Including GST)</u> stands deleted. However, since there is no possibility to change the Bill of Quantity ( <b>BoQ</b> ) in the financial bid in CPPP portal, the bidders are requested to quote the same value in column 2 & 3. In case, the values are different, the lowest value will be considered as valid quote.
7	Bidders had requested for applicability of Permanent total disability compensation and temporary total disability for students and project staff in extending benefits in GPA policy.	<ol> <li>Temporary total disability compensation is applicable for temporary/project staff only.</li> <li>All other benefits are as per standard IRDA norms.</li> </ol>
