The following would be the mandates for the committee :

It will handle all student complaints and grievances related to academic matters, availability of academic and research facilities, student-facing relationships and other students' affairs.

It will also function as the Standing Disciplinary Committee as per clause 4 of the student's handbook of code of ethic and conduct along with standard procedures to enquire into the alleged case and recommend suitable disciplinary action.

It will also act as "mentoring cell" in terms of Clause 6 .3.2 of the UGC regulation on curbing the menace of ragging in higher educational institution, 2009, issued vide memo No F 1-16/2007 {CPP-II} in April 2009.

It will make a review of the student's code of ethics and conduct and make recommendations. As mentoring cell, the Committee would be conducting the following activities, every year. Conduct orientation programs, counselling sessions, etc, publicize anti-ragging measures, cross verify undertaking from candidates/ students, cross verify undertakings from the parents/ guardians and help in Anti-ragging policy formulation.

The Committee will be in force for two years and the term of the special invitee shall be for one year.
