## 2. Job Profile/Responsibilities

- (a) Client consultation and identify psychological, emotional or behavioural issues.
- (b) Diagnose psychological, emotional or behavioural disorders and administers programs of treatment.
- (c) Develop and implement treatment plans and therapeutic processes.
- (d) Taking care of emergencies (on-call basis).
- (e) Should be able to work in shifts.
- (f) Work with student communities, staff and their dependents to improve psychological wellness and to address mental health issues.
- (g) Help students define goals, plan, action, and gain insight.
- (h) Treats psychological disorders to effect improved adjustments utilizing various psychological techniques; selects appropriate treatment approach and plans frequency, intensity, and duration of individual, group, and family therapies.
- (i) Provides crisis intervention in situations requiring immediate psychological treatment.
- (j) Help clients define goals and plan action to achieve personal, social, educational and vocational development and adjustment.
- (k) Monitor client progress through regular meetings or sessions.

## 3. **Duration**

Engagement is purely temporary on a contract basis, initially for a period of **one year** and renewable annually up to a maximum duration of **five years**, based on the satisfactory performance and discretion of authorities of the Institute.
