#### **2. Job Description**

The candidate should accomplish the following tasks:

- Oversee the management of the BSL-3/ABSL-3 facility.
- Veterinary care of laboratory animals at BSL3 Facility.
- Assist researchers in animal experimentation.
- Preparation and implementation of SOPs, facility record keeping and updating on Animal Colony Management Software.
- Any other activity assigned by the Chair of the facility from time to time.

#### **3. Duration**

Engagement is purely temporary on a contract basis, initially for a period of one year and renewable annually up to a maximum duration of five years, based on the satisfactory performance and availability of funds. An annual increment of up to 10% is permissible in case of extension of contract, subject to individual case evaluation. The contract tenure will commence from the date of joining.
