1. Indian Institute of Science (IISc), Bangalore, invites applications for **09 positions (UR-05, OBC-01, SC-01, ST-01, EWS-01)** of LIM Project Trainee in the J.R.D Tata Memorial Library (JRDTML) at the Institute. The details are as follows:

2. Job Description:

- (a) Traineeship provides an opportunity to learn while working on different functions & services of the library using emerging tools and technologies. Assist in the acquisition of content (both print and Digital), Classification, Cataloguing & Organization of Information Resources, Circulation and Reference Services, Document Delivery and Research Support Services.
- (b) Selected Project Trainees are expected to work 6 days a week on any of the three shifts, including night shift duties and public holiday duties.

3. Duration

Engagement is purely temporary on a contract basis for a period of **2 years**. For candidates previously employed at IISc through appointments made by the HR Department, the duration of their prior service will be counted in the maximum permissible tenure of two years.

An increment of up to 10% is admissible in the case of extension, based on the performance of the candidate and the recommendation of the Competent Authority.

4. Selection Procedure

Based on the number of applications received, the written test may be conducted only for shortlisting the candidates.

The final selection will be based on the candidate's performance in the interview.
